National. Key components of HMG include a coordinated access point, family and community outreach, data, and health provider outreach. In February of 2020, HMG-PC launched a centralized access point (CAP) with two family resource navigators. By December of 2020, the family resource navigators were taking over 200 calls per month. In March, HMG-PC also established a diaper bank network. Ten diaper banks across the county serve as a touchpoint for outreach and information sharing, reaching over 600 children each month. The diaper banks, while initially a pandemic response effort, will be a permanent resource in the community that will enhance the system's ability to reach families in need.
